

# PUBLIC NOTICE

**SECTION 14(1) ROAD TRAFFIC REGULATION ACT 1984  
HEREFORDSHIRE COUNCIL  
OPENREACH MAINTENANCE WORKS (22-406), HEREFORDSHIRE  
TEMPORARY CLOSURE ORDER 2022**

NOTICE is hereby given that Herefordshire Council intend, under the provisions of Section 14(1) Road Traffic Regulation Act 1984 (as amended), to temporarily prohibit the use by vehicles on the roads mentioned in Schedule 1 of the Order as attached.

The alternative routes for those affected by the proposal will be signposted locally but details of specific alternate route may be obtained by contacting 01432 261800 or please use our online form to contact us via [www.herefordshire.gov.uk/contactus](http://www.herefordshire.gov.uk/contactus).

The said closures are required to enable Openreach to undertake maintenance works on or near the said roads, and the likelihood of danger to the public while the works are taking place.

There are exemptions in the Order to permit pedestrian access (and/or vehicular access at the discretion of the Herefordshire Council or statutory undertaker) to any land or premises having a frontage to the above said highway affected where there is no other form of access, and to any access allowing the necessary works to be undertaken.

The said Order will come into force on the 8<sup>th</sup> April 2022 and will remain for a maximum period of 18 months, (unless extended with the consent of the Secretary of State) or until any said works which it is proposed to be carried out have been completed, (whichever is the earlier), or until determined by Herefordshire Council. However, the schedule of works is expected to be completed within the dates shown in Schedule 1 of the Order.
